FROM THE PRESIDENT

I was greatly honored to be elected as IFA Chairman at IFA's 83rd annual meeting held in Istanbul in May 2015.

It is a privilege to represent this important industry at the global level! As IFA Chairman, I have learned that decision makers and influencers in our increasingly urban world do not always know how food is grown and produced, and while welcoming innovation in many areas, tend to almost instinctively view modern agricultural practices as "unsustainable."

But when presented with clear, science-based evidence, they learn that mineral fertilizers, for example, are responsible for roughly half of the food that ends up on our plates, or that

fertilizers are based on "natural" rather than man-made elements, namely nitrogen from the air, and phosphate and potash ores.

They learn that nutrients that are removed by successive harvests must be replenished in order to keep soils healthy and fertile, and that organic sources of nutrients are not always sufficient, thus requiring integrated nutrient management.

They also appreciate learning about nutrient stewardship initiatives and quickly grasp the

At the General Meeting on 19 November 2015, Mr Rakesh Kapur, IFFCO, India was elected Vice President of the Association.

Following the resignation of Mr Arifin Tasrif in November 2015, from the Executive Board and from the Board, Mr Rakesh Kapur was appointed Chairman of the Finance Committee by the Board at its meeting on 19 November 2015.

PRODUCTION AND INTERNATIONAL TRADE COMMITTEE



In 2015 the Production and International Trade Committee published 70 statistical reports for IFA members, covering mainstream fertilizers and intermediates. The Capacity Tollgates Task Force finalized the series of tollgates for its capacity reporting, and the PIT Service launched a series of surveys for initiating the collection of data on selected specialty fertilizers.

The Committee also organized its first webinar for IFA members on feedstock issues, "Shifts in Energy Markets – Implications for the Fertilizer Industry". The Task Force on Eastern Europe and Central Asia Statistics developed its roadmap for the collection of statistics in this region. The Task Force on China Fertilizer Statistics finalized statistical templates for exchanging relevant information between IFA and the Chinese fertilizer industry.

The Trade Contract Task Force completed the draft assessment note on the merits of establishing a unified IFA Trade Contract, on which an internal consultation with a selected group of members is planned in early 2016. The PIT Service participated in several industry events and engaged with the FAO, UNEP, IEA and OECD on industry statistics, forecasts, and issues related to fertilizer feedstock supply.

The 36th IFA Production and International Trade Conference took place in Tampa, Florida, in September. There was an emphasis on innovation, emerging fertilizer products, feedstock issues, capacity developments and logistical challenges.

AGRICULTURE COMMITTEE

In January IFA, the International Water Management Institute (IWMI), IPNI and IPI jointly published "Managing Water and Fertilizer for Sustainable Agricultural Intensification", which discusses management practices to enhance nutrient use efficiency and water productivity and synergies between the two. Reaching out to a larger audience, IFA published a four-page brief for policy and industry leaders as well as infographics for the general public summarizing key messages.

As an input to the International Year of Soils IFA released "Managing Fertilizers to Enhance Soil Health", co-authored by Bijay Singh and John Ryan, which emphasizes fertilizer's benefits for soil health when applied according to best management practices.



In March IFA and the Fertiliser Association of India (FAI) co-organized a national seminar in Delhi on "Sustainable Fertilizer Management for Soil Health" focusing on fertilizer subsidy policy, fertilizer best management practices, specialty fertilizer products and outreach to farmers. IFA and the International Zinc Association (IZA) co-organized the 4th International Zinc Symposium in September in São Paulo, at which updated knowledge on the benefits of zinc in improving crop production and human health was shared.

The Fertilizer Demand Session in Istanbul addressed fertilizer-related policy changes in China, fertilizer subsidy policy in India, yield gaps internationally, and regional nutrient use efficiency trends.

In 2015 the Agriculture Service started to consider expanding its market intelligence programme to complementary indicators such as yield gaps, nutrient use efficiency and the specialty fertilizers market.

TECHNICAL AND SHE COMMITTEE

IFA's biennial Global Safety Summit took place in Vancouver, Canada, in March. Supported by the Canadian fertilizer association, this conference highlighted best practices leading to Safety, Health and Environment (SHE) excellence in operations. In addition, the 140 participants from 30 countries were invited to visit the local Neptune Bulk Terminals and to attend various social events. A unique combination of thinking-outside-the-box plus world-class practice and networking opportunities made this event a full success.



The fourth edition of IFA's voluntary triennial Energy Efficiency & CO2 Emissions Benchmark for ammonia producers saw

participation by 66 plants located in 26 countries, representing approximately a quarter of global ammonia production. Total performance has improved for each survey since this activity started in 2004 (average net Energy Efficiency +4% and net CO2 Emissions -9%).

The Committee commissioned an independent analysis to allow producers to obtain the most up-to-date information and guidance on safe phosphogypsum usage. A peer-reviewed 120-page report, "Phosphogypsum: Sustainable Management and Use", is now available to IFA's membership. This document allows other fertilizer associations and companies to follow up with local assessments in the future.

COMMUNICATIONS AND PUBLIC AFFAIRS COMITTEE



2015 began strongly for IFA's Communications and Public Affairs team with the official launch in January of the Committee, made up of 55 members and eight Working Groups and Task Forces.

2015 was the UN International Year of Soils, a theme of great importance to IFA and its members. The Committee launched two websites: Nutrients4Soils and Growing Smart Together, a platform that disseminates the diverse viewpoints of stakeholders and experts on topical issues in agriculture (the first of these is soils). Growing Smart Together was presented to the public during Global Soils Week in Berlin (19-23 April).

Important progress was also made on UN outreach, and on joint strategies with private sector representatives in relation to the UN.

In May IFA participated in the annual meeting of the International Agri-Food Network (IAFN) in preparation for the 42nd Session of the UN Committee on World Food Security (CFS) in October. At the CFS, IFA led a delegation of seven industry members and IFA's Chairman Abdulrahman Jawahery was invited to speak at a meeting with FAO Director-General José Graziano da Silva.

Due to its continuous efforts on the Sustainable Development Goals (SDGs) during the year – with the organisation of a workshop in January and an outreach mission to the UN in March – IFA was the sole private sector delegation invited to take part in the meeting of the Inter-Agency and Expert Group (IAEG) on SDG indicators in November, shortly after the adoption of the SDGs by the UN General Assembly in September.

The Committee also regularly participated in meetings of the Business Advisory Committee (BIAC) to the OECD on Food and Agriculture, as well as meetings of the Farming First Coalition.

IFA REGIONAL INITIATIVES

AFRICA FORUM

IFA was actively involved in African matters in 2015, especially in relation to the African Fertilizer Financing Mechanism (AFFM). At the meeting of the AFFM Governing Council (of which IFA is a member) in July in Addis Ababa, Ethiopia, IFA pledged financial support from the industry to AFFM and set forth the conditions for such support. The announcement was welcomed by the African Union Commission and the African Development Bank.

IFA will now turn its attention to assisting with revisions of the AFFM's work programme priorities and establishing a well-defined relationship with the African Fertilizer and Agribusiness Partnership (AFAP).



Following a meeting with the Common Market for Eastern and Southern Africa (COMESA) in September in Lusaka, Zambia, IFA agreed to support COMESA's 500 small and medium enterprises (SMEs) initiative. This initiative, implemented by AFAP, aims at helping to develop SMEs involved in the fertilizer value chain in the COMESA region.

EASTERN EUROPE AND CENTRAL ASIA OUTREACH

IFA's outreach to Eastern Europe and Central Asia (EECA) included member meetings in Belarus, Kazakhstan and Russia. In Moscow the Secretariat hosted a well-attended event at the Russian Producers Association (RAPU), where the programme of next year's Annual Conference in that city was discussed. Several action points of mutual support were agreed, such as sharing of best practices and the development of regional statistics.

The participation of EECA company representatives in IFA's global working groups keeps increasing.



ASIA OUTREACH

IFA China Initiative: In late 2015 the IFA China Consultative Group, comprising CEOs of prominent Chinese IFA member companies, released two declarations to the attention of the IFA Board of Directors and members, in which they shared their unanimous commitment to promote nutrient stewardship in China and to support IFA product stewardship by initiating in 2016 the process for certification under the IFA Protect & Sustain programme.

IFA Viet Nam Outreach: In October 2015 IFA and PetroVietnam Fertilizers and Chemicals organized a half-day outreach seminar in Hanoi. The seminar was a unique opportunity to present IFA major activities and shared IFA principles on nutrient stewardship and product stewardship to close to 90 participants from government, industry and trade in Viet Nam.

IFA EVENTS

IFA organises several high-level events each year that bring together industry specialists and decision makers to exchange views on key issues relevant to the fertilizer industry. Designed to facilitate the sharing of information and global networking, these events are attracting more and more participants thanks to their organisation, the pertinence of their themes, and the quality of the guest speakers.

Indeed, in 2015, IFA's Annual Conference, held in Istanbul on 25-27 May, attracted more than 1400 people from 73 countries, proving its particular importance to the industry's leadership.


AWARDS

THE NORMAN BORLAUG AWARD

Every year since 1993, IFA has granted the Norman Borlaug Award to a person whose research or extension work has led to significant advances in crop nutrition. The award allows IFA to promote research and knowledge transfer on efficient and effective fertilizer use.

Professor Michael McLaughlin is the laureate of the 2015 award, which recognizes excellence in crop nutrition research in developed countries.

A Science Fellow of Australia's Commonwealth Scientific and Industrial Research Organisation (CSIRO) and Research



It has been diffused globally thanks to the University of Adelaide's Fertiliser Technology Research Centre. Professor McLaughlin has also employed new methods to examine and benchmark fertilizer behaviour and effectiveness. He has used isotope tracing and dilution methods to determine the fate of added fertilizer.

Professor McLaughin is an avid communicator of his research. In addition to supervising over 20 postgraduate research students from Australia, Brazil, China, Ecuador, Germany, Iran, Malaysia and Sri Lanka, makes his knowledge available to farmers and growers in Australia. Following a severe drought in that country in 2006, he and two of his colleagues quickly wrote and published a factsheet detailing how to conduct nutrient management under drought conditions, along with recommendations for fertilizer management in the following season. These recommendations are still being used.



THE GREEN LEAF AWARD

The IFA Green Leaf Award is awarded every two years to an IFA member whose production complex (single site) has shown outstanding performance in Safety, Health and Environment (SHE) in fertilizer production.

In 2015 an in-depth review of numerous applications by an independent jury concluded that the ammonia and urea production of Yara Brunsbüttel in Germany came out first. The Green Leaf Award 2015 was presented by Esin Mete, President of IFA, and Jim Prokopanko, Chairman of IFA's Technical and SHE Committee, during the 2015 Global Safety Summit in Vancouver, Canada.

The first and second runners-up were Rotem Amfert Negev Ltd. (Israel) and IFFCO Phulpur Unit (India), respectively. Special recognitions included a Green Leaf Excellence Award for Qafco (Qatar), the 2013 winner, which again obtained the highest score among the competitors, and a Green Leaf Best Progression Award for Shriram Fertilisers and Chemicals (India) to acknowledge significant SHE improvements in fertilizer production between 2013 and 2015.

FINANCE

In 2015, total operating income and expenditure were almost at the same level as in 2014 and amounted to €8.19 million and 8.16 million respectively, against €8.39 million and 7.96 million in 2014. Income from subscriptions for 2015 remained at the level of the previous year.

Referring to conferences and meetings, revenue from the Annual Conference in Istanbul was at the level of Sydney in 2014 but several other events organized in 2015 resulted in a lower income compared to those organized in 2014.

Operating expenditure slightly increased by about 2.6 per cent in 2015 versus 2014. Expenditure increases were seen for the sustainable fertilizer partnership programme; external consultancy fees; staff costs; as well as the general expenditures. In contrast, some savings were also made, more specifically in the organizational costs of the conferences and meetings.

Referring to financial activity, a surplus of some €57,000 was recorded in the accounts, against about €253,000 in 2014. This substantial difference resulted from the loss in the change in fair value of investments, which amounted to around €106,000 at the end of the year, against a positive result of some €89,000 in 2014. This situation is explained by the



fact that the market value of the financial investments at 31 December 2015 was significantly lower than in December 2014, on account of the continuing downturn of the financial markets registered throughout the year.

Whereas IFA ended 2015 with an operating surplus of about €30,000, taking into account financial activity, the overall surplus for 2015 reached €69,600 after taxation (€17,000). This surplus was added to the association's reserves.

Details of the Association's financial situation in 2015 are provided in the "Audited Accounts at 31 December 2015" attached to the Annual Report.
