From rethinking value chains to unlocking new financing models and forging unconventional alliances, innovation offers pathways that can cut through political divides and market barriers. But for these solutions to endure, they must also be viable, bankable, scalable, and capable of attracting sustained investment and delivering measurable impact.

The roundtable will explore practical strategies for deploying innovation that strengthens systemic resilience, mobilizes capital and talent toward high-impact solutions, and creates new forms of cross-border collaboration beyond traditional diplomatic channels.
